He wants to preserve the unique quality of life we value here in Flower Mound!


Andy has the government experience and proven community leadership to be a strong voice for Flower Mound. **He is the only candidate in this race from Flower Mound.**


We need a positive change in the Commissioners Court. Andy's opponent has:


